DESCRIPTIONS OF WORKING-LUNCH WORKSHOPS ON VARIOUS APPROACHES TO THE HISTORY OF PSYCHOLOGY

WORKSHOP.

The Problem- or Issue-Centred Approach.

Description:

The goal of this workshop is to learn the meaning of the problem-centred approach and how to use it. First, a survey will be conducted of the general problems within psychology at the turn of the nineteenth into the twentieth century. This will be followed by a detailed treatment of three controversies which arose among great psychologists in the years around 1900. These are:

- (1) The controversy between Wilhelm Dilthey (1833-1911) and Hermann Ebbinghaus (1850-1909) in 1894-95: Psychology - Natural or Cultural Science?
- (2) The controversy between James R. Angell (1869-1949) and Edward B. Titchener (1867-1927) in 1896-98: Structural or Functional Psychology?
- (3) The controversy between Sigmund Freud (1856-1938) and Alfred Adler (1870-1937) in 1905-11: The Unconscious - Fact or Fiction?

This workshop will concentrate on contextual and structural approaches in the social sciences, with special reference to the history of psychology and sociology. These approaches emphasize the interdependence of three classes of historical variables: the natural milieu, socio-economic structures, and events. Contextualist topics will include an approach to Aristotle's biological works; Alexandre Koyre and the contextual approach to the history of natural sciences; presentism vs. contextualism in the interpretation of Leonardo's notion of the erect retinal image; Galileo's Saggiatore passage about the mathematical language of nature; Freud's monograph on Leonardo; a study in the abuse of words and symbols; the context of Galton's and Pearson's scientific propositions about hereditary intelligence: a study in the fascist roots of racist psychology; the fallacies of a great psychologist: Thorndike and anti-immigration legislation.

The first session will consider the scope of the Marxist approach to the history of psychology and the social sciences. In the second meeting problems of method involved in analyzing the genesis of societal requirements for scientific problem solutions will be discussed with special reference to the problems of the social demand for education in the future labour force. The workshop will finally focus on problems of method involved in analyzing the development of new fields and approaches of research in the social sciences as a reaction to the development of social needs for scientific problem solutions. These will be discussed with special reference to the place of psychology in the emerging division of labour in the social sciences which refer to processes of education and qualification.

The purpose of CHEIRON is to promote international and multidisciplinary cooperation in scholarly activity and research which touches on the history of the behavioral and social sciences. The organization's aims are to strengthen and increase professionalization of scholarly research in the history of the behavioral and social sciences, to broaden scientific perspectives by close cooperation between scholars of all countries, and to provide a broad perspective on contemporary science through the study of the history of differing disciplines and their interactions. The Society is engaged in efforts to promote publications designed to further these goals. The first sponsored work is HISTORICAL CONCEPTIONS OF PSYCHOLOGY, edited by members Mary Henle, Julian Jaynes, and John Sullivan.

CHEIRON was formed in October, 1968. Annual meetings have been held at Princeton University (1969), the University of Akron (1970), in New York City, with the New School for Social Research, Herbert Lehman University and New York University as joint hosts (1971), the University of Calgary in Alberta, Canada (1972), the State University, Plattsburg, New York (1973), and the University of New Hampshire in Durham (1974).
